City Council Minutes  
September 19,2022

On this day September 19,2022, at 6:03 pm, Mayor Susan Hubbard called a regular City Council meeting to order with council members Chuck Richoz, Clara Kay, Greg Branson, Eric Maloy and Eleta Taylor. The department heads present were: Norma Hallmark, Stephen Lucas, Mandy Thomas, Mike Maberry, and Guy McKee and Bucky Elkins.

Eric Maloy gave the invocation.

In the Mayor's comments, she reminded the citizens that any comment made should be during time the agenda item is being discussed.

Greg Branson made a motion to approve the minutes from the August 15, 2022; August 22, 2022; August 29,2022 and September 12, 2022. Clara Kay seconded the motion. The motion passed unanimously.

Chuck Richoz made a motion to approve departmental monthly reports; seconded by Eleta Taylor. The motion passed unanimously.

Greg Branson made a motion to approve the Interlocal Agreement with Wood County for the Fire Marshall Fiscal Year 2022-2023. Clara Kay seconded the motion. The motion passed unanimously.

Greg Branson made a motion to approve the Interlocal Agreement with Wood County for the Emergency Management Fiscal Year 2022-2023. Eric Maloy seconded the motion. The motion passed unanimously.

Eric Maloy made a motion to approve the Interlocal Agreement with Wood County for Fire Protection and Emergency Fiscal Year 2022-2023; seconded by Chuck Richoz. The motion passed unanimously.

Council members made a motion to approve for setting the Tax Rate for the fiscal year 2022-2023 at \$.8200 per \$100 valuation. Mayor Susan Hubbard calls for a vote as follows: Chuck Richoz voted to approve and set the tax rate. Clara Kay voted to approve and set the tax rate. Eric Maloy voted to approve and set the tax rate. Eleta Taylor voted to approve and set the tax rate. Greg Branson voted to approve and set the tax rate. The motion so carried.

Eric Maloy made a motion to appoint Brandon Baker and Clara Kay to HCDC; seconded by Eleta Taylor. The motion passed unanimously.

Eric Maloy made a motion to approve the Taser Contract with Axon Enterprise for Hawkins Police Department. Eleta Taylor seconded the motion. The motion passed unanimously.

Greg Branson made a motion to approve City Ordinance Chapter 71.04 Disorderly Operation of Motor Vehicles. Eric Maloy seconded the motion. The motion carried.

Eric Maloy made a motion to approve the Letter of Intent to purchase 2022 Ford F-150 Responder with equipment for Police Department. Clara Kay seconded the motion. The motion so carried.

Chuck Richoz made a motion to approve the purchase of a generator with \$75,000 limit for Water/Sewer Department. Clara Kay seconded the motion. The motion passed unanimously.

Eleta Taylor made a motion to accept Resignation of Municipal Judge Stephen Lucas as of October 1, 2022. Chuck Richoz seconded the motion. The motion passed unanimously.

Greg Branson made a motion to adjourn the meeting; seconded by Eric Maloy. The motion passed unanimously.
