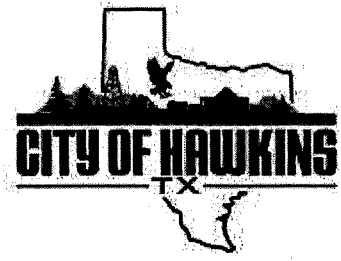




City of Hawkins

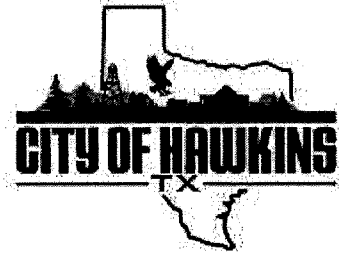

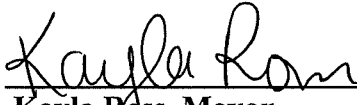
